MINETA President & CEO When I first took on the role of President and CEO of Momentum two and half years ago, I consistently saw one of our clients in the lobby and outside one of the organization's offices. For confidentiality purposes, I will call him George. We eventually struck up a conversation that lasted about a year and half. He was in and out of services but would still come to the office regardless of his enrollment or housing status. As with so many folks qualifying for services, George's symptoms would ebb and flow from serious to more serious. Last winter, I saw him walking in the rain on the street and pulled over to talk to him as I had not seen him in months. He said he was doing ok, but had lost a lot of weight and looked very frail. I asked if he wanted a ride to the office, but he said "thanks" and kept going along his way. He said, "Bye Dave. Good seeing you." This small but meaningful interaction weighs heavily on my heart knowing George may no longer be receiving the care he needs to live a healthier life.

We are truly blessed to work in the behavioral health community and assist so many individuals and families. It is in fact a privilege. We must work together to treat, feed, employ, and house those who are most in need and who, for example, might be sitting right in front of us on the curb in front of our favorite cafe. This is Momentum's commitment as we look forward to our next 20 years. Through innovative approaches to treatment, dynamic and culturally competent staff members, and the support of our community, we are ready to see what the future holds for mental health in Santa Clara County. # WHAT WE DO

#### MOMENTUM OFFERS A WIDE ARRAY OF PROGRAMS AND SERVICES THAT INCLUDE

- Transitional Age Youth (TAY) and Adult Full Service Partnership programs.
- Comprehensive outpatient case management, rehabilitation groups, mental health and medication services.
- Supported housing and independent living options throughout Santa Clara County.
- Employment Services program for those individuals that wish to return to work.
- A 45-bed transitional board and care facility that includes on-site wellness services, physical healthcare and transitional case management.



In addition, to meet the immediate needs of individuals in crisis and to prevent the need for higher levels of care including hospitalization, we offer four Crisis Residential Programs and the first Adult Crisis Stabilization program in Santa Clara County.

Momentum for Mental Health presents over 40 years of experience providing Crisis Residential Services (CRS)

locally in Santa Clara County. Clients come to these programs through a variety of referral sources including locked settings (acute hospitals, Institutes of Mental Disease [IMDs], jails, state hospitals, and state prisons) who are expected to have difficulty functioning in the community outside of institutional settings. In addition we offer FSP-90, a program that helps persons with long histories of institutional living reintegrate into the community. The majority of our programs across the agency provide a 24/7, 365 days per year, live-person on call system designed to help with unplanned crisis.

We partner with Foothill Clinic, a San Jose based Federally Qualified Health Center (FQHC) that provides clinic based primary care services at two of our largest service locations. Momentum also partners with another FHQC, Mayview Community Health Clinic, a primary care services provider in North County.

Through a collaborative partnership with Starlight Community Services. Momentum's Raising Early Awareness and Creating Hope (REACH) program serves youth ages 10-25 who are either showing early signs or have recently been diagnosed with a psychosis. Through individual and group therapy as well as wraparound services for families, REACH provides the resources necessary to decrease the major symptoms of mental illness before they have a major impact on a youth's daily life.

We have long offered dual diagnosis groups and are currently expanding our service array to accommodate those with a substance use issue. We are increasing staff competencies in this area by recruiting staff members who have experience working with individuals who struggle with substance use while improving our existing staff competencies by providing training and support to become Certified Alcohol and Drug Abuse Counselors (CADAC certification).






### GENDER




#### **PRIMARY DIAGNOSIS**
